#### **FAN ID**

A FAN ID is an obligatory document for the 2018 FIFA World  $Cup^{TM}$  matches attendance, which is necessary for the spectators to enter the stadiums.

A FAN ID is a small laminated form with personal information. A FAN ID should be issued in advance.

A FAN ID can be obtained only by the tickets holders or individuals who have the right to purchase tickets for the 2018 FIFA World  $Cup^{TM}$ .

A FAN ID is issued once for all the 2018 FIFA World Cup $^{\text{TM}}$  matches.



The FAN ID holders can arrive to the territory of the Russian Federation without the Russian visa during the period starting 10 days before the first match, during the 2018 FIFA World Cup $^{\text{TM}}$  events and they can leave the territory of the Russian Federation during 2018 FIFA World Cup $^{\text{TM}}$  events as well and during the period ending 10 days after the last match of the 2018 FIFA World Cup $^{\text{TM}}$ .



A FAN ID and a ticket allow to use free the public transport of the 2018 FIFA World Cup™ host cities and the special trains between the host cities on matches days.

A FAN ID is issued free.

### **HOW TO GET A FAN ID**

### REGISTRATION OF THE APPLICATION

On the www.fan-id.ru website. File an application for a FAN ID in advance on the www.fan-id.ru website.

To file an application you need a ticket reservation number or a ticket number and details of your ID document.

or



At the FAN ID Distribution center. File an application for a FAN ID at any FAN ID Distribution center.

In order to file an application at a FAN ID Distribution center you need your original ID document (a birth certificate for children under 14 years) and a form with a match ticket reservation number or a match ticket number.



# APPLICATION APPROVAL

Wait for your application to be approved. The notifications on the status of your application are received via SMS and e-mail.



## RECEIPT OF THE FAN ID



At the FAN ID Distribution center. Once approved, you can receive your FAN ID at any FAN ID Distribution center.

You need to present your original ID document (a birth certificate for childrer under 14 years), specified in the application for a FAN ID and an application number (optional).





Postal delivery if you filed your application via the website. Once approved, you can receive your FAN ID by mail (for foreign citizens) / at the post office (for the Russian citizens).



#### MEMO FOR PASSENGERS





For export/import of prescribed medicinal drugs containing narcotic and psychoactive substances IT IS REQUIRED TO FILL A PASSENGER'S CUSTOMS DECLARATION AND POSSESS NECESSARY MEDICAL DOCUMENTS such as prescriptions, doctor's notes or an extract from medical record.



For weapons, their major parts and ammunition export/import, A PASSENGER'S CUSTOMS DECLARATION IS REQUIRED to be filled. Also the PERMISSION FROM A MINISTRY OF FOREIGN AFFAIRS is required.



For exporting cultural valuables, a passenger's CUSTOMS DECLARATION IS REQUIRED to be filled in. Also the permission to take out cultural valuables issued by the Ministry of Culture of the Russian Federation is necessary.



For export of rare and endangered species of wild plants and animals, their parts and (or) derivatives included in the endangered species lists of the Russian Federation, a passenger's customs declaration is required to be filled. The permission issued by ROSPRIRODNADZOR (FEDERAL SERVICE FOR SUPERVISION OF NATURAL RESOURCES) is also required.



Items of personal use may be imported duty-free by aircraft, if their cost does NOT EXCEED AN AMOUNT EQUIVALENT TO 10 000 EUROS.



For other means of transport, the amount shall NOT EXCEED 1 500 EUROS, and overall weight shall NOT EXCEED 50 KG.



One person above 18 may import no more than 3 LITERS OF ALCOHOLIC BEVERAGES AND BEER duty-free



One person above 18 may import the following tobacco goods duty-free: 200 CIGARETTES OR 50 CIGARS, OR 250 GRAMS OF TOBACCO, or any of these in assortment with overall weight no MORE THAN 250 grams.



CASH AND TRAVELLER'S CHEQUES may be imported duty-free if overall amount does NOT EXCEED 10.000 US DOLLARS.



### MAY NOT BE ALLOWED TO EXPORT FROM THE CUSTOMS UNION'S TERRITORY:

- more than 5 kg of fish and sea products;
- more than 250 grams of sturgeon caviar;
- more than 10 liters of fuel contained in a separate tank.
