

# CHECKLIST FOR CROATIAN VISA IN THAILAND

<b>Admissibility</b>	<b>Visa application form:</b> filled out and signed by the applicant, or a parent or legal guardian on behalf of minor (under the age of 18). For a minor, a legal guardian/parent shall submit visa application.	
	<b>Travel document:</b> issued in the last 10 years, 2 empty pages, expiry date exceeding requested visa by 3 months.	
	<b>Face photograph:</b> in colour, 35x45 mm; with neutral facial expression and shown person's cheeks, chin and forehead, if the person is wearing scarf for religious or medical reasons.	
	<b>Visa fee:</b> 60 EUR *35 EUR fee covers citizens of Russia, Moldova, Georgia, Ukraine, Armenia and Azerbaijan.	
	<b>Or exempted from visa fee</b>	
	<b>Submitted <u>not</u> earlier than three months</b> before the intended trip	
<b>Non-Thai citizens:</b> proof of legal residence in Thailand.		
<b>For minors:</b> Birth certificate; if applicable: the decision of the competent authority on appointing the legal guardian.		
<b>Minors travelling alone</b> or without parent or legal guardian: an original authorisation (signed and legalized) of a legal guardian or parent, containing personal information of the legal guardian, purpose, place and length of stay in Croatia, as well as the period for which the authorisation is issued.		
<b>Travel medical insurance:</b> valid for the territory of Croatia, covering any expenses which might arise in connection with repatriation for medical reasons, urgency medical attention, emergency hospital treatment or death during the stay. The minimum coverage € 30.000.		
<b>Means of transportation:</b> return plane/train/bus/boat ticket; driver license and auto-registration certificate if travelling by car; If the person is travelling to a third country, proof of itinerary and visa, if necessary.		
<b>Accommodation:</b> booking hotel, private or other accommodation, real estate title deed or lease, etc. Accommodation can be provided by the guarantor or hosting party - it shall be stated in the letter of guarantee or invitation or in a written request.		
<b>Social &amp; professional status:</b> certificate of employment, school attestation, proof of registered commerce, etc.		
<b>Financial means:</b> pay or pension slips and/or bank account statements for the last 3 months, proof of scholarship, etc. Persons without their own resources: statement on sponsorship with proof of the sponsors' financial funds.  Funds must be equivalent to EUR 70 per day of the visit. If the visitor has submitted a proof of ensured accommodation, he/she must possess amount equivalent of EUR 30 per day of the visit. Exception: if stated in the <i>letter of guarantee or written request</i> , that host or guarantor is covering all expenses.		
<b>Proof of the purpose of stay in Croatia:</b>		
• <b>Tourism:</b> proof of accommodation		
• <b>Private or business visit:</b> original Letter of Guarantee (filled and certified) with proof of solvability of the guarantor;		
• <b>Members of official delegations:</b> letter of competent state authority confirming that the applicant is a member of its delegation and a Letter of (official) Invitation (exonerated from: proof of financial means and social & professional status);		
• <b>Other purposes:</b> invitation to a professional education/conference/event, etc.		
<b>Members of the immediate family of a citizen of Croatia/EU/EEA/Switzerland:</b> proof of the family tie (birth or marriage certificate with photocopy of the ID card of the Croatian/EU/EEA/Swiss citizen; exonerated from proof of financial means & social and professional status & travel insurance & accommodation)
