CHECKLIST FOR MEDICAL TREATMENT VISA

	For all applicants - Translation of all Arabic documents into English is mandatory		
1	one applications duly completed and signed		
2	Original passport and one photocopy of all relevant passport pages (data page, pages with previous Schengen visa, etc.)		
3	1 declaration signed by applicant (under section 54 (6) AufenthG/German Residence Act)		
4	1 declaration signed by applicant (under section 55 (2) AufenthG/German Residence Act)		
5	one recent passport photograph (not older than 6 months		
6	Letter from local employer, stating qualification, salary and start date of employment certified by chamber of commerce or translated trade license if self-employed		
7	For persons escorting the patient: confirmed hotel booking (full address of the hotel must be written in the application: full name, street name, no. of the building, city and city code) or a confirmation from the clinic that also the accompanying persons are accommodated in the clinic		
8	Proof of sufficient finance for the stay, e.g. by up-to-date personal bank account statement for the last three months		
9	1 photocopy of the insurance policy for a valid Travel and Health insurance covering the territory of the Member states of the Schengen agreement and with a minimum coverage of EUR 30,000 (Thirty thousand) for medical expenses.		
10	If medical costs are borne by the government of Saudi Arabia: Written confirmation from the Saudi Arabian Embassy in Berlin or Verbal Note from the Saudi Arabian Ministry of Foreign Affairs or Verbal Note from the Saudi Arabian Ministry of Health stating all costs are borne by the Saudi Arabian government		
11	If medical costs are borne by the employer: Confirmation letter of employer, that he is covering all costs for treatment. The employer has to prove his capacity of covering these costs (for example through bank statements		
12	Medical report issued by the doctor in charge of the treatment in Saudi Arabia		
	Additional documents required for non-Saudi nationals residing in Saudi Ara	bia	1
13	Flight ticket or flight reservation including return flight and 1 photocopy thereof		
14	Iqama (Saudi Arabian residence permit) and exit/re-entry visa for Saudi Arabia, covering the entire requested visa validity and Family Iqama copy		
	Place Note: For children under 19 years both parents must sign the application/declaration for		

Please Note: For children under 18 years both parents must sign the application/declaration form /questionnaire. Passport copies of both parents to be attached. For children registered in a parent's passport a separate application form has to be filled.

Additional Information:

- All applications submitted by a representative other than the applicant will have to include a signed authorization letter from the applicant, failing which the application will not be accepted.
- If patients claim that they cannot come personally t the Embassy for interview due to their state of health, a doctor's written confirmation in this respect has to be submitted.
