4.	An Indian Government visa application form duly filled in online Your form should be signed in the box under the photograph on page 1. This signature will be scanned and should match the signature on your passport You should validate the data on your form and accept the declaration on page 2 by signing at the bottom of page 2		
5	An original letter confirming the applicant's admission into an Indian university, school or higher education establishment to follow a full-time course, including a detailed description of the study programme and its duration \underline{OR} an original invitation letter from the Indian company OR NGO addressed to the applicant specifying the nature of the internship, the terms and its duration. This document should be written in English on official letterhead and be stamped and signed (no scanned or faxed copies will be accepted)		
	Bank Guarantee If the studies are financed by the applicant: an original bank guarantee letter issued by the bank, on bank letterhead paper, in the name of the applicant, testifying their ability to meet expenses of a minimum of 500 € per month to cover study fees, accommodation and living expenses in India for the duration of the stay If the studies are sponsored by a third person: an original bank guarantee letter issued by the bank, on bank letterhead paper, in the name of the third party, testifying their ability to sponsor the applicant for a minimum of 500 € per month to cover study fees, accommodation and living expenses in India for the duration of the stay.
