• The Internship Visa will be granted immediately after completion of graduation/ post-graduation but the gap between the completion of graduation/ post-graduation and the commencement of the internship should not be more than one year.

5	A letter from the Indian Company/Educational Institution/NGO concerned sponsoring the applicant for the internship programme and clearly indicating the period of internship and the salary (if applicable). The letter should be stamped and signed	
•	<b>Salary</b> In case of internship in a Company, the applicant being sponsored for internship should draw a minimum remuneration of Rs. 7.80 Lakhs per annum.
