STUDENT VISA APPLICATION - SINGAPORE

New and Returning Students

You must lodge your application at the New Zealand Visa Application Centre (VAC) in Singapore. For more information about the VAC, visit: www.vfsglobal.com/newzealand/singapore. It's important you provide all the relevant information requested below so we can process your application promptly. Application forms are available from our website: www.immigration.govt.nz/forms.

Alternatively you may be able to apply on-line for some visa types. You can access our On-line visa application service through our website www.immigration.govt.nz/

Non-English documents must be translated to English by a translation company and submit both the Non-English and English translated documents. Self-translations will not be accepted.

When providing original documents with your application ensure they are accompanied by a standard photocopy.

All forms must be properly completed and each signature section signed. Mark N/A to question(s) not applicable to you.

Confirmation that the education provider has assessed and is satisfied the prospective student meets the course





competencies and enrolment provision (section 7.1) as set out in the Code of Practice for the Pastoral Care of International Students.

- Foreign fee-paying students who are under 18 years old must provide a statement from their education provider
 confirming that the student's accommodation complies with the Code of Practice for the Pastoral Care of
 International Student.
- The vacation periods and the credit rating of the programme of study.

Official receipt for payment of course fee. The length of your student visa is based on the course fee you have paid. (eg. If you have paid fee for 1 semester, your visa, if approved, will be valid for 1 semester).

Applicants living outside their home country, submit evidence of residence status for the country currently living in, such as Permanent Residence visa, employment pass, work permit, dependant pass, long-term visit pass or student pass
Financial Requirements

Courses which are more than 36 weeks required fund of NZ\$15,000 per year

Courses which are less than 36 weeks required fund of NZ\$1,250 per month or a letter from the education provider confirming accommodation and other living expenses are included as part of a prepaid package.

Evidence of funds, please provide one of the following:

- If you are sponsored, a completed ORIGINAL Financial Undertaking for a Student form (INZ1014). Please refer to page 1 of the form for supporting documents you must submit.
- If you are self-sponsored, bank statements for the last 6 months in your name or a letter from the bank stating the balance amount in your account.
- Letter of award of scholarship stating the scholarship amount, duration of the scholarship and what it covers.

Additional Documents Required For Returning Students

- Evidence of your previous study performance and attendance
- Letter from the education provider. It needs to state your student's status, the course name, annual school fee and whether the student is full-time or part-time.

If there were medical concerns in your last application, the 36 months validity for your last medical certificate may not apply. Please confirm the validity of your previous medical certificates when renewing your visa.

Additional information request

Immigration New Zealand reserves the right to request additional information in the course of assessing an application and to retain information and documents on file.

Processing time

Approximately 15 working days. This is an estimate only and is subject to change depending on the type of visa application and/or whether more information is needed to support an application. However, we commit to keep in touch with you throughout the processing of your application.
