	A Covering letter from the shipping company / maritime agency containing following details:		
	Name and rank of the applicant, vessels name and arrival date at the port in Denmark, Date of joining vessel, the name and address of the handling agent in Denmark.		
	 Itinerary that the seafarer will follow to arrive in the member state of destination/transit (including date and entry point (airport) to the Schengen area. 		
	Overseas travel medical insurance valid for all Schengen-countries. The insurance has to cover the applicant for at least 30,000 Euros or equivalent, for all risks e.g. accident, illness, medical emergency evacuation etc.		
	Flight reservations for the onward destination.		
	Proof of accommodation in case of an overnight stay.		
	A valid visa for the country of destination.		
	Covering letter from your Organization or company stating the applicant's name and rank, vessels name and arrival date at the port in Denmark, date of joining vessel, the name and address of the handling agent in Denmark.		
	Copy of employment contract / appointment letter (showing duration of employment).		
	Confirmation by letter / fax from port agent in Denmark.		
	Seaman's book.		
	One set of Colored copy of the entire passport including blank pages. If having old passport colored copies of first and last page and UK, US, Australia, Canada and Previous Schengen Visa Copies if any.
