	Copy of <b>name or surname change certificate,</b> if applicable.			
	<b>Proof of integration</b> : into the country of residence: Household registration record.			
	Documents from employer/company:			
	- Documents proving the business activities of the company (import-export license, proof of prior business, certificate of registration of the company*) - Other documents which show the existence of trade or work relations - If the applicant is employed: 1) the last three payslips, 2) labour contract, 3) decision letter from the employer confirming the business trip - If the applicant is a company owner or self-employed: certificate of registrations of the company* and statement of taxes payment are required.			
	Documents from sponsor/host in Denmark: ☐ Invitation from reference			
	<u>Invitation</u> from a firm or an authority to attend meetings, conferences or events connected with trade, industry or work. Invitation must state the specific purpose of the visit, information on previous contacts with the applicant, how did they establish their contact – both from reference in Denmark and reference in other Schengen countries. We highly recommend to use the form in the Danish Immigration Service <u>VU1</u> or use an <u>online invitation</u>			
	If the applicant is sponsored and/or hosted in a private accommodation: - A copy of passport or national identification card of the sponsor/host in Denmark - If the sponsor/host is a foreigner, a copy of permanent residence permit is also required Bank account statements on the turnover during the last three months of the sponsor/host when its/his/her financial means are not proven otherwise.			
	Documentation of funds to cover the trip.  According to the Danish Immigration Service you must have the necessary means to pay for your stay and return trip. As a general rule, you must have at your disposal approx. DKK 350 per day. A smaller amount may be accepted if you are staying in a private home and your host will cover all costs. If you are staying at a hotel, the amount must be greater, approx. DKK 500 per day. 	Documentation providing clear information about the trip, including:  1.Round trip reservation/booking Flight/train/ferry reservation with fixed travel dates of maximum 90 days to Denmark and other Schengen countries. (Do not buy the ticket until a visa has been granted).  2. Confirmation of accommodation in Denmark (and other Schengen countries, if the applicant is going to other countries on the same trip)  3. Entry tickets for fairs and congresses (if any)			
	Original compulsory travel medical insurance, covering the entire of intended stay, valid for all Schenger countries covering any medical expenses of at least 30,000 Euro as well as urgent medical attention emergency hospital treatment or death during your stay, repatriation to Vietnam/resident country
