	- Parental consent for the minor child that is either travelling abroad alone or with only one parent:		
	a) An official parental consent for the planned travel abroad must be submitted, in case that one of the

	b) Or the declaration of consent letter signed by the parent/s who is/are not traveling with the minor

If submitting documents to prove family relationships from countries other than Thailand, legalization from competent Embassy or Consulate is required.
