	Letter from the employer (not older than 30 days from the date of the application) - addressed to the

	Both parents must be present at the Visa Application Center with the minor.			
12	A minor traveling accompanied or unaccompanied must have a consent letter signed by both parents. Copy of the parents' passports must be attached.			
	Birth certificate must be legally translated either in English or in Italian.			
	School certificate confirming the enrolment of the minor must be provided.			
13	UNEMPLOYED/RETIRED/ STUDENTS/MINORS			
	Applicants must provide a guarantee letter by the family member covering the travel costs. Proof of			
	relationship, A copy of the passport or of the Qatar ID of the guarantor must be attached.			

DECLARATION

Regulations:

- 1. The above checklist should be filled up with correct information.
- 2. Documentation provided by all applicants should be presented in Italian or English.
- 3. Application form needs to be duly filled and signed.
- 4. Visas can be requested up to three months before the planned trip.
- 5. For minors travelling without their parents/legal guardian, an original authorisation signed by their parents/legal guardian and copy of passports are required.
- 6. Applicants should provide flight/train bookings or car rental reservation also for travels internal to other Schengen areas.
- 7. Applicants should submit templates that can be downloaded through the specified links.
- 8. The delivery of passports will be done UPON submission of the application. No exceptions will be accepted.
- 9. Once the application has been submitted, the applicant cannot withdraw his/her own passport. The passport will be delivered only at the end of the process.
