<ul style="list-style-type: none"> Fully completed and signed Long Stay Visa Application Form of the Republic of Latvia: https://epak.pmlp.gov.lv/NVIS.EService001.WebSite/ 		
<ul style="list-style-type: none"> Two recent passport size photograph (Not older than 3 months, size: 3,5 - 4,5 cm, white background and neutral expression necessary, no head or face covering acceptable except for religious reasons; please do not staple). 		
<ul style="list-style-type: none"> Original passport with UAE residence permit and the Emirati ID card, all valid for at least three months longer than the intended stay. The passport must have been issued within the last 10 years, must be in a good shape and have at least 2 empty pages. The applicant needs to provide a photocopy of the identity page of the passport, the UAE residence permit and any previous Schengen visas from the last 3 years. 		
<ul style="list-style-type: none"> Positive Decision Copy of the Office of Citizenship and Migration Affairs of Latvia (OCMA/PMLP) granting residence permit in Latvia. 		
<ul style="list-style-type: none"> Letter from your University in Latvia about full time studies in Latvia and that you have been matriculated in the University. 		
<ul style="list-style-type: none"> Flight ticket reservation. 		
<ul style="list-style-type: none"> Travel insurance certificate valid for 30 days. The minimum coverage of 42,600 EUR including the costs of urgent medical attention and/or emergency hospital treatment in case of an illness as well as repatriation in the event of death. Medical insurance policy can be obtained in applicant's country of residence, or in any other country, or taken out by the inviting person. It is important that the insurance meets all the above requirements.
