Applications should be submitted in person (also babies and children) and the following documents must be submitted:

:	For every document, you must provide the original and one copy.  The documents are to be presented in (or translated to) Dutch, English, French or Spanish.  The documents submitted will not be returned. Only the travel document will be returned.

•	Your passport or travel document must be valid for at least 3 months from the date on which you leave the Schengen area.  Your passport or travel document must have at least 2 empty visa pages.  Your passport or travel document cannot have been issued more than 10 years ago.

2.3	If the minor travels without his/her legal guardian: consent of the parental authority (both parents) or legal guardian shall be provided either through a legalised certificate issued by competent authority or by a form signed at the consulate premises.
