

## Checklist for visa application Airport transit

Applications should be submitted in person (also babies and children) and the following documents must be submitted:

- For every document, you must provide the original and one copy.
- The documents are to be presented in (or translated to) Dutch, English, French or Spanish.
- The documents submitted will not be returned. Only the travel document will be returned.

1.	Application
1.1	A completed and signed Schengen visa application form.

2.1	A passport or other travel document.

## Please note:

- Your passport or travel document must be valid for at least 3 months from the date on which you leave the Schengen area.
- Your passport or travel document must have at least 2 empty visa pages.
- Your passport or travel document cannot have been issued more than 10 years ago.

3.	Evidence of legal residence

4.	Photo
4.1	A passport photo that meets Dutch passport requirements. This photo cannot have been taken more than 6 months ago and must bear a clear resemblance.  See: <a href="mailto:photo-guidelines.">photo-guidelines.</a>

5.	Proof of travel
Note: r	make travel reservations which you can cancel, in case your visa request will be refused.
5.1	Copy of flight/travel reservation/s including details of the itinerary and the flight reservation number.

5.2	Bank statements for the last three months, including the current balance, or other verifiable evidence of sufficient means of subsistence during the intended stay, e.g. credicard copy and credit card statement.

5.3 Original letter from employer/sponsor in Saudi Arabia stating employment status, position held, date of recruitment, length of contract and whether renewable or not, as well as salary, attested by the Chamber of Commerce.

The letter must include the purpose of the visit and cost coverage guarantee, whether it is

covered by the company or by the applicant. The letter from the sponsor must include the name and contact details (including mobile phone number) of the responsible person from the company. 6.3	At least $\in$ 30.000 of medical costs are reimbursed, including hospital care, emergency treatment and repatriation (including in the event of death).
