2.3	If minors (under 18) are not accompanied by one of the parents: parental consent of both parents and copies of their id/passport. The consent of the parents/legal guardians should be required only if the minor travels alone or only with one parent. Exceptions are made if the single parent with whom the minor is to travel holds sole custody.
