Online applications for new Lesotho Exemption Permit now open in South Africa

- To replace LSP (Lesotho Special Permit) which is set to expire on 31 December 2019
- Submission of online applications and appointment scheduling via VFS Global's website open from 18 November 2019
- Fingerprints and supporting document submissions to start from 25 November 2019 at ten VFS Global centres in South Africa

VFS Global has announced the commencement of applications for the new Lesotho Exemption Permit (LEP) project by the Department of Home Affairs, South Africa to help regularise the stay of Lesotho nationals already residing in South Africa. In order to continue to legally work, study or conduct business in South Africa, valid LSP (Lesotho Special Permit) holders must submit applications online through VFS Global's website (www.vfsglobal.com/LEP/SouthAfrica) to replace their current LSP's, which will expire on 31 December 2019. The cut-off date for submission of online applications is 31 March 2020.

Once the online application submission is completed, LSP holders will be allocated appointments for the mandatory submission of fingerprints and supporting documents. This will commence from 25 November 2019 at ten VFS Global centres across South Africa.

The new LEP entitles the holder to work, study and/or conduct business in South Africa legally, but does not allow them the right to apply for Permanent Residence, irrespective of the period of stay in the country. The permit is not automatically renewable or extendable nor does it allow the holder to change conditions of their permit while staying in South Africa. Those LSP permit holders who wish to convert their status to a mainstream visa should proceed to apply for such a visa from Lesotho.

Commenting on the project, Mr. Jiten Vyas, Regional Group COO, VFS Global, "The work we have done so far in the government within the citizen services space stands as a strong testimony to our world-class service capabilities and enhanced applicant experiences that we are able to offer, irrespective of the scale of operations, as a trusted partner to the Department of Home Affairs, South Africa. VFS Global's role is limited to scheduling appointments, acceptance of applications, enrolling biometrics, acceptance of fees, submission of applications to Department of Home Affairs and returning the outcomes back to the applicant/s. The adjudication of the permit applications is done by the Department of Home Affairs (DHA). VFS Global has no role in the decision-making process.

LEP Requirements

Valid LSP holders must submit the following documents as part of the LEP application process at the nearest VFS Global centre:

- Lesotho passport valid for more than 6 months at time of application
- Lesotho ID card
- Copy of the LSP permit
- Evidence of employment in the case of an application for work rights
- Evidence of business in the case of an application for business rights
- Evidence of an admission letter from a recognised learning institution –in the case of an application for study rights

Please note:

- LEP permits will be issued for a maximum period of 4 years, effective from 01 January 2020 and expiring on 31 December 2023, notwithstanding the date of application
- Cut-off date for submission of applications is 31 March 2020
- After the online application submission, LSP holders will be allocated appointments for the required submission of fingerprints and supporting documents from 25 November 2019 at the following VFS Global centres across South Africa
