Supporting documents shall be translated into English, Finnish or Swedish and shall be presented in the following order. Originals shall be presented in Visa Application Centre. Please be prepared to show original documents at the VAC, but submit only photocopies of documents. The Embassy does not return any other documents to applicant than passports.

Passport/ Valid travel document and one photocopy of ID page. Passport/ travel document must be valid for a minimum of 3 months after the planned journey, issued within the previous 10 years and have at least 2 blank pages.			
Schengen visa application form duly completed, dated and signed by the applicant.			
Recent color passport photograph , which fulfills ICAO standards (taken within the past six months, white or light background, neutral face expression).			
Valid UAE residence permit. Permit must be valid for three months after your departure from the Schengen area.			
Flight reservation(s) , including domestic flights in Finland and to/from Schengen-area.			
Bank account sheets; Applicant's recent (last three months) bank account sheets. Account sheets must be originals and signed/stamped by the bank.			
Travel medical insurance , which must be valid for the whole duration of the travel. The minimum amount of the insurance coverage is 30 000 euros and it must be valid in whole Schengen area or worldwide. The insurance policy details must be included.			

Checklist for Medical/Sport/Study (short term)

Invitation letter from Finland. Medical: Invitation letter from the health care provider stating invited person (full name, d.o.b., passport number), the intended treatment, diagnosis and plan for the treatment, signature/profession and contact information of the inviter. Pre-payment or other proof of sufficient financial means to cover the medical treatment and related expenses, such as insurance coverage. Sport: Invitation letter from the event coordinator stating invited person (full name, d.o.b., passport number), description of the event (date, time, place) signature/profession and contact information of the inviter. Study (short term): Invitation letter from the university or institution in Finland and/or entry ticket or registration for an exhibition or a conference. If the trip includes visits to the several Schengen Member states; invitation or proof of conference must be provided for all countries to be visited. If the visa applicant will be giving a verbal presentation or a poster presentation in a conference, the name of the presentation should be attached to the visa application Students should present a recent, official and signed letter from the school, college or university, stating date of issue, name of the applicant and type of studies, number of lessons (hours) per week and attendance record.			
Letter from the employer which is not more than one month old: headed letter with name, date of issue, address, telephone number and position of signatory, including information of monthly amount of salary, start date of employment and position at the company. Multiple entry request cases the employer must request and explain the need for multiple entry visa and state the time it is requested for. Self-employed should present an evidence of business ownership (trade licence) in the United Arab Emirates.

Applicant(s) under 18: Minors travelling without their parents/legal guardian: birth certificate, original authorization signed by their parents/legal guardian in front of a visa officer or duly legalized and copy of passport(s) of parents/legal guardian.			
Family members of Finnish citizens (exempted from visa fee, no travel insurance required): Proof of being a family member; marriage certificate or birth certificate • Married in Finland: Finnish marriage certificate OR extract from the Finnish population register VTJ • Married in any other country: marriage certificate AND extract from the Finnish population register VTJ.
