4.	Letter from local sponsor	
	Stating designation, salary and start date of employment in the UAE or Legally translated trade license if self- sponsored.	
5.	Leave Certificate from the Employer (NOC with leave details)	
6.	Confirmed hotel booking - full address of the host/the hotel must be written in the application: full name, street name, no. of building, city and city code.	
7.	Up-to-date personal bank account statement for the last 6 months - original and stamped	
	from the bank.

8.	Overseas Medical Insurance copy - covering the territory of the Member States of the Schengen Agreement	
	and with minimum coverage of EUR 30, 000 for medical expenses, repatriation and evacuation.	
9.	Flight ticket or flight reservation including return flight and 1 photocopy thereof.
