## Checklist for Affidavit by a parent when applying for a child's passport, in India OR Overseas

### Section A: About Affidavit from parent when applying child's passport in India

This affidavit is required when parent(s) is/are applying for their child's passport in India and the other parent is in Australia. The parent in Australia has to certify that he/she has no objection to a passport being issued to his/her child in India or overseas.

**Important Note: -**

- If both the parents are in Australia, separate affidavits are required from each parent.
- If parent(s) is/are Australian, the affidavit form needs to be apostilled by DFAT before submitting to VFS centres
