- 1 Birth registration to complete online <http://indiancitizenshiponline.nic.in> ☐
 - **IMPORTANT: Documents should be uploaded in English only. Please also note down Temporary application ID which may be required for future rectification if any.**
 - A copy of the full registration file should be given along with the application
- 2 An Indian Government passport application form duly filled in online ☐
 - Thumb print of the child should be on the form in lieu of signature
- 3 Four photographs conforming to Indian Government norms as per specifications mentioned on our website ☐
 - Please note photographs available in photo booths in France are not compatible with Indian norms
 - Photos should be glued to the form
 - Photo service complying to the Indian norms is available in our offices – please ensure that the photo is bright
- 4 Two Personal Particulars forms (PP Form) duly filled in and signed with photos pasted in the top right-hand corner (See Download Forms section on VFS website) ☐
 - Please note that for question 8 (a) and (b) you must provide an address in India
- 5 Annexure H and Declaration Minor forms signed by both parents (See Download Forms section on VFS website) ☐
- 6 Photocopy of both parents' passport (first and last pages as well as any pages including any endorsements) and originals for verification ☐
- 7 Photocopy of the French titre de séjour of both parents and originals for verification ☐
- 8 Original birth certificate with English translation ☐
 - Please note that any certificate issued outside of India must be apostilled by the “cour d’appel” or Ministry of Foreign affairs (Quai d’Orsay)
- 9 Marriage certificate of parents with English translation ☐
 - Please note that any certificate issued outside of India must be apostilled by the “cour d’appel” or Ministry of Foreign affairs (Quai d’Orsay) and should be given in the original
- 10 Photocopy of one of the following to prove your address: electricity, gas, landline/mobile telephone bill ☐
- 11 Declaration form: to be filled when submitting any application ☐
- 12 Additional documents mentioned below as per your case ☐

LIST OF ADDITIONAL DOCUMENTS

If one of the parents is holding a non-French passport

- A letter from the Embassy or Mission of the concerned country stating that the child has not acquired nationality of his/her parent ☐

If case one parent is not in France

- Annexure D (see Download Form section of VFS website) attested by Indian magistrate or Indian Mission abroad **OR** Annexure C (see Download Form section of VFS website) with presence of single parent ☐

In case of single parent applying without consent of other parent (child born out of wedlock or whereabouts of other parent unknown)

- Annexure C (see Download Form section of VFS website) N.B. Single parent has the choice to mention the name of other parent or not ☐
- Annexure D signed by parent present to apply (see Download Form section of VFS website) ☐
- If applicable, joint affidavit for minor born out of wedlock (see Download form section of VFS website) ☐

In case only one parent can be present to submit application

- Annexure D signed by both the parents (see Download Form section of VFS website) ☐
