How to calculate the cost of your visa?

Many factors may influence on the final price of your visa (nationality, origin, type of visa, services). Please browse through all the below tables in order to calculate the price of your visa. You may find assistance with the 3 examples provided. Unless otherwise mentioned, fees are cumulative from one table to another.

CHANGE OF FEE AS PER NATIONALITY OF THE PASSPORT

Important: certain nationalities are granted free or reduced **visa fees**; the applicants of such countries must however pay the **service fees**, the **ICWF fee** and the **referral fees**.
