**Please read instructions carefully before filling the application form.**

1. Five forms are to be filled in by each applicant, with one copy of passport size photograph affixed to each form.
2. Forms which are incorrectly filled or incomplete in any respect are liable to be rejected. If at any stage it is found that the information furnished is incorrect or that some information has been deliberately withheld, visa is likely to be refused or cancelled, even if already issued.
3. Please mention clearly the checkpoint of entry into /exit from India in section 13.

**4. It is the responsibility of the applicants to collect two copies of the application form and verify the visa particulars when they collect their passports. They shall carry these forms with them while travelling as it may be required for submission at the checkposts of Entry / Exit. Entry may be refused if visa is not accompanied by these forms .**

5. Applications may be deposited in person or through Travel Agents, Monday to Friday (except Government of India holidays) at Consulate General of India Durban or Johannesburg. Applications by post should be sent only by registered post at least **five weeks** in advance of the proposed date of travel. In all cases where return of passport is required by mail, a stamped, self-addressed, recorded delivery envelope should be enclosed.
6. The visa fees payable (see section on visa fees for applicable fees) which should be paid either in cash or demand draft made payable to Consulate General of India, Durban or Johannesburg (as applicable). Credit Cards are not accepted.
7. In certain cases, visa can be issued only on receipt of clearance from the concerned authority in India. In such cases, visas may be available only after 8/10 weeks and issuance will be subject to approval by the concerned authority.
8. **While every effort is taken for prompt processing, the High Commission or Consulate will not be responsible for any delay / loss of passport or other documents sent by post or otherwise.**
