The tracking number will be sent via SMS at the time of dispatching the document and it will take about 1~2 working days to receive the shipment.</p>

1. Visa application must be submitted to **India Visa Application Centre(IVAC) in Seoul.**
2. Please transfer visa fee to India Visa Application Centre's bank account and enclose the confirmation receipt along with your application/other documents. **(ATM, CD, Mobile or Phone banking is not acceptable and non-refundable)**
3. **Only Tourist Visa** is available for the service.
(For non-Korean passport holders, postal service is available **unless interview is required**)
4. Please fill out your expected date of journey to India on the top of the post envelope. (Eg.: DD/MMM/YYYY)
5. **Validity of visa begins from the date of visa issued at Embassy of India in Seoul**, so please plan for your trip accordingly.
6. If your application is incomplete or phone number is incorrect, the submission for visa processing may take longer.
