- 1. Before using postal service, please see **checklist at our website** and then send your passport and documents to us by post. (Visa Information Checklist)
- 2. Visa application must be sent to **India Visa Application Centre(IVAC) in Seoul** by post. Postal fee for visa application to IVAC in Seoul should be prepaid by applicants.
- 3. Please transfer visa fee to India Visa Application Centre's bank account and enclose the confirmation receipt along with your application/other documents. (ATM, CD, Mobile or Phone banking is not acceptable and non-refundable)
- 4. **Only Tourist Visa, Business visa applicants** who do not need an interview at the Embassy are able to use postal service.
- 5. Please fill out your expected date of journey to India on the top of the post envelope. (Eg.: DD/MMM/YYYY)
- 6. Validity of visa begins from the date of visa issued at Embassy of India in Seoul, so please plan for your trip accordingly.
- 7. If your application is incomplete, the submission for visa processing may take longer or your application may be returned to the mailing address you sent.
- 8. If your phone number is incorrect, the submission for visa procssing may take longer.
- 9. India Visa Applicatoion Centre is closed on public holidays and weekends. Please visit VFS India Visa Application Centre website to see information of public holidays.
