- If minor applicant is traveling with one of the parents: Original consent letter from District, legalized through the Ministry of Foreign Affairs, to be signed by the parent who is not traveling together with the minor, translated into English, birth certificate (copy and original) with translation in English and house registration (copy and original) with translation in English.
- If minor applicant is traveling alone: original consent letter to travel abroad from the District, legalized through the Ministry of Foreign Affairs, signed by both parents, translated into English, birth certificate (copy and original) with translation in English and house registration (copy and original) with translation in English.

^{*}Documents required for minors (under 18 years old)

- If one of the parents passed away: death certificate (original and copy) together with translation in English.
- If one of the parents has exclusive parental power: The Court Decree ordering it, legalized through the Ministry of Foreign Affairs, must be shown, translated in English. If submitting documents from countries other than Thailand, legalization from competent Embassy in Thailand is required.

Translation and insurance service are available at the Visa Application Center.

The cost of this service is 1500 Baht (including VAT) per person, which is in addition to the Schengen visa fee and the VFS service fee.
