Acquisition of covid negative certificate and quarantine measure All passenger need to get certificate of negative COVID-19 test result conducted within 72 hours of the departure time of the flight (format is on the MOFA Homepage). On arrival to Japan, all the passengers are required to take COVID-19 test, and do not use public transport as well as 14 days of home quarantine etc. (the detail is on the Ministry of Health, Labour and Welfare Homepage) is mandatory.
