

Checklist for visa application | Airport transit

Applications should be submitted in person (also babies and children) and the following documents must be submitted:

For every document, you must provide the original and one copy.

•	The documents are to be presented in (or translated to) Dutch, English, French or Spanish. The documents submitted will not be returned. Only the travel document will be returned.

	 Your passport or travel document must be valid for at least 3 months from the date on which you leave the Schengen area. Your passport or travel document must have at least 2 empty visa pages. Your passport or travel document cannot have been issued more than 10 years ago. 	
2.3	Travelling with minors If the minor is travelling with only one parent, written consent certified by public notary of the other parent or guardian, except in cases of a parent having sole custody or guardianship of the minor;

2.4	If the minor travels alone (without parents), written consent, certified by public notary, of both parents or guardians having custody or guardianship of the minor;

2.5	Copies of the passport of the parents. If not applicable, birth certificate of the applicant and copies of the ID cards of the parents.

3.	Evidence of legal residence		
3.1	Evidence of legal residence in the country you are applying from, e.g. a passport, visa or residence permit and a copy of work permit (if applicable). Residence permit should be valid for at least 3 months after departure from Schengen.

4.1	A passport photo that meets Dutch passport requirements. This photo cannot have been taken more than 6 months ago and must bear a clear resemblance. See: photo guidelines.

5.1	Flight reservation of return or round ticket. If the applicant is travelling to several Schengen States, proof of intra-Schengen flight reservation, train itinerary or car rental.

5.2	Proof of lodging Hotel reservations, rental of holiday home or campus residence reservation. If the applicant intends to stay with a family member or a friend, proof of sponsorship and/or private accommodation from the host. If applicant is travelling to several Schengen States, proof of lodging in each of them. See Proof of sponsorship form.
