## PEOPLE ELIGIBLE FOR INTERNSHIP VISA:

- The Internship Visa will be granted immediately after completion of graduation/ post-graduation (masters level) but the gap between the completion of graduation/ post-graduation and the commencement of the internship should not be more than two years.
- The internship visa will be granted to persons wishing to travel to India as part of a VIE program. We will accept complete files only (list of documents given by BusinessFrance). A salary minimum of € 12,000 will be required.

•	<b>Salary</b> In case of internship in a Company/NGO or Educational institution, the applicant being sponsored for internship should draw a minimum remuneration of Rs. 7.80 Lakhs per annum (900€ per month).

7	<b>Proof of graduation:</b> diploma or attestation from the school. In the case of a Master's student, you must have validated both years of the course and be waiting for the diploma so that a certificate can be accepted.
