## LIST OF DOCUMENTS FOR PAKISTANI PASSPORT HOLDERS

- 1 **Original passport valid for a minimum of 6 months (or for the validity requested, if greater) and having at least 3 blank visa pages (of which 2 must be side by side)** ☐
- 2 **A photocopy of the data page of the passport** ☐

**Seven (7) identical files must be made with the following documents in this order:**

- 1 **An Indian Government visa application form duly filled in online mentioning your Pakistani nationality / origin** ☐
  - Your form should be signed in the box under the photograph on page 1. This signature will be scanned and should match the signature on your passport
  - You should validate the data on your form and accept the declaration on page 2 by signing at the bottom of page 2
- 2 **One photograph conforming to Indian Government norms as per specifications mentioned on our website** ☐
  - Please note photographs available in photo booths in France are not compatible with Indian norms
  - Photos should be glued to the form in the box provided on page 1
  - Photo booths complying to the Indian norms are available in our Paris and Marseille offices
- 3 **The hand filled reference form for Pakistanis (in block letters, photocopies not accepted)** ☐
- 4 **Sponsorship Certificate (not required for each city / place to be visited and in the following cases: in case the applicant has visited within the past two years; for Student, Medical, Business or Conference Visas)** ☐
- 5 **Copy of a valid French resident permit** ☐
- 6 **A detailed description of the proposed journey and itinerary in India** ☐
- 7 **A recent work attestation from your employer in your name** ☐

## LIST OF DOCUMENTS FOR APPLICANTS OF PAKISTANI ORIGIN

- 1 **Original passport valid for a minimum of 6 months (or for the validity requested, if greater) and having at least 3 blank visa pages (of which 2 must be side by side)** ☐
- 2 **A photocopy of the data page of the passport** ☐

**Two (2) identical files must be made with the following documents in this order:**

- 1 **An Indian Government visa application form duly filled in online mentioning your Pakistani nationality / origin** ☐
  - Your form should be signed in the box under the photograph on page 1. This signature will be scanned and should match the signature on your passport
  - You should validate the data on your form and accept the declaration on page 2 by signing at the bottom of page 2
- 2 **One photograph conforming to Indian Government norms as per specifications mentioned on our website** ☐
  - Please note photographs available in photo booths in France are not compatible with Indian norms
  - Photos should be glued to the form in the box provided on page 1
- 4 **The hand filled reference form for Pakistanis (in block letters, photocopies not accepted)** ☐
- 5 **For non-French passport holders: copy of a valid resident permit** ☐
- 6 **Attestation issued by the Embassy of Pakistan stating either:** ☐
  - That the applicant never possessed a Pakistani passport or a Pakistani identity card ☐
  - That the applicant has possessed or currently holds a Pakistani passport or a Pakistani identity card. If so, please give the details (number, validity...) of these documents. ☐
- 7 **Optional documents that may contribute to speed up the processing of your application:** ☐
  - For members of International Organisations (United Nations, World Bank, International Monetary Fund...): letter from the institution explaining the necessity for the applicant to visit India ☐

- Documents proving that the applicant is married to an Indian national or a person of Indian origin
- Documents proving that the applicant has strong family ties in India
