## Application guidance for nationals of Indonesia, Philippines, Vietnam and India

Nationals of Indonesia, Philippines, Vietnam and India with ordinary MRP (Machine Readable Passport) / e-passport in compliance with the ICAO (International Civil Aviation Organization) standard, who wishes to apply for a Multiple Visa for a stay of up to 30 days and are eligible for one of the following categories:

- A) Individual who has a travel record as temporary visitor to **Japan** in the last three years and who has the ability to pay the travel expenses
- B) Individual who has a travel record as temporary visitor to Japan and multiple travel records as temporary visitor to **G7** countries (Canada, Germany, France, Italy, USA, UK) in the last three years
- C) Individual with sufficient financial capacity
- D) Spouse or children of the individuals who are mentioned A), B), or C) above
