



## AUSTRIA - CHECKLIST FOR MEDICAL VISIT

	<b>One application completed and signed by the applicant.</b> Note: For accompanying children under 18 years old, both parents / legal guardian must sign the application/declaration form/questionnaire. Passport copies of the father and mother / legal guardian have to be attached.	
	<b>2 recent passport photograph</b> Note: Passport size with white or plain light color background ; must be recent (not older than 6 months) ; must be without head covering for male applicants	
	<b>Confirmed hotel booking</b> (full address of the hostel/ hotel must be written in the application: full name, street name, building name or number, city, Email address of the hostel/ hotel, Telephone Number of the hostel/hotel and city code)	
	<b>Air ticket reservation including return flight</b>	
	<b>Original letter of the employer stating (for Non Saudi National)</b> <ul style="list-style-type: none"> <li>• 02 IQAMA photocopies</li> <li>• Valid Exit and Re-entry copy</li> <li>• The purpose of the visit to Austria,</li> <li>• The salary and the date of employment,</li> <li>• Certified by the Chamber of Commerce.</li> <li>• If sponsor is different, No objection certificate (NOC) from sponsor as per Iqama</li> </ul>	
	<b>Written confirmation of appointment with doctor in charge of treatment in Austria</b>	
	<b>If medical costs are borne by the Government of Saudi Arabia:</b> Written confirmation from <ul style="list-style-type: none"> <li>• The Embassy of Saudi Arabia in Vienna OR</li> <li>• Verbal Note from the Ministry of Foreign Affairs in Saudi Arabia OR</li> <li>• Verbal Note from the Ministry of Health Saudi Arabia stating all costs are borne by the Government of Saudi Arabia</li> </ul>	
	<b>If medical costs are borne by the employer</b> <ul style="list-style-type: none"> <li>• Up-to-date personal bank account statement for the last 3 months or letter of employer confirming that all expenses will be covered by employer</li> <li>• 1 photocopy of the insurance policy for a valid Travel and Health insurance covering the territory of the Member states of the Schengen agreement and with a minimum coverage of EUR30,000 for medical expenses</li> </ul>	

**Please note:**

- The visa must be applied for either in person or through a representative
- All documentation must be submitted in English language
- For children registered in a parent's passport, a separate application form has to be submitted.
- Original documents must be presented; additional photocopies may be required
