

Checklist for short term „C“ Visa

Please note:

- Every applicant over the age of 12 must submit her/his biometric data (fingerprints) along with the application

- Applications have to be submitted at least 15 days prior to the intended time of travel. However, processing time in individual cases may take up to 45 days.

Sr. No	Schengen Visa – Category C	Remarks
1	Online application (Visa C) form duly completed and signed Note: for children under the age of 18 both parents must sign an authorization letter. Passport copies of the parents/legal guardians must be attached. Proof of present legal guardianship must be provided.	
2	2 recent passport pictures, not older than 6 months, please visit for proper specification: http://www.passbildkriterien.at/	
3	Proof of flight ticket booking or flight reservation including return flight and full travel itinerary	
4	Proof of accommodation (i.e. hotel reservation, proof of rental or ownership of real estate in the Member State of destination, confirmation of private accommodation, mentioning that the host will cover the accommodation costs confirmation of accommodation by the company inviting the applicant, mentioning that the company will cover the accommodation costs, etc.)	
5	Proof of valid travel or international health insurance covering the entire territory of all Schengen member states with a minimum coverage of € 30.000,- for medical expenses valid for the entire travel period.	
6	Original passport and a copy of the passport Note: The passport must be valid for a minimum of three months after your intended departure from the Schengen States and must bear the holders signature. The passport shall contain at least two blank pages and must have been issued within the previous 10 years.	
7	Copy of all previous Schengen Visa with entry and exit stamps	
8	UAE residence permit, must be valid a minimum of three months after your intended departure from the territory of the Schengen States.	
9	Copy of all UAE residence permits of the last ten years.	
10	Copy of the Emirates ID	
11	Original letter from local sponsor (NOC) Indicating qualification, salary, beginning of employment or sponsorship in the UAE, duration of employment as well as time frame of work leave, expected date to resume duties and confirmation of upright employment relationship after return from the trip (i.e. applicant will resume work after trip on XXX). The NOC should not be older than 1 month and signed/stamped by the employer. Sponsored family members (spouse, students, etc.) have to enclose a copy of original birth and marriage certificate including an English translation. For business owners a copy of the valid original trade license must be presented.	
12	Original personal bank account statement for the last three months signed and stamped by the bank with salary income and traceable financial means	
13	Valid contact information = e-mail <u>and</u> mobile number	
14	Applications for minors: NOC from school/university (indicating the ongoing registration and time of absence)	

15	Business travel: Invitation letter from a company or an authority to attend a meeting, conference or event or other documents which show the existence of trade relations or relations for work purposes (e.g. confirmed registrations for trade fairs or congresses etc).	
16	Medical treatment: A document issued by the medical institution in the Member State of destination confirming that the applicant will receive medical care in that institution mentioning duration of treatment. Pre-payment or other proof of sufficient financial means to cover the medical treatment and related expenses, such as insurance coverage.	
17	Short term study or training: A certificate of enrolment at an educational establishment for the purposes of attending vocational or theoretical courses within the framework of basic and further training; Student cards or certificates of the courses to be attended	

IF APPLICABLE:

18	NOC letter from school/university indicating registration and leave.	
19	EVE or GVE = electronic liability declaration. These are the only accepted forms of liability declarations For more information please visit: https://www.bmi.gv.at/202/Fremdenpolizei_und_Grenzkontrolle/Einreise/start.aspx	
20	Airport transit: Valid visa for the country of next or final destination. Proof of the intention of carrying out the onward journey, copy of ticket or reservation of ticket for onward journey.	
21	For minors: copy of the birth certificate and marriage certificate of their parents	
22	For minors, who travel without their parents: original authorisation signed by their parents/legal guardian in front of a visa officer or duly legalised and copy of passport(s) of parents/legal guardian.

- All documents must be submitted in German or English language
- For children registered in their parent's passport a separate application must be submitted Application forms can be downloaded at:
