



Checklist for INDIVIDUAL TOURISM

Australian and New Zealand citizens do not need a visa when they travel to Belgium for business or for personal travel. The stay in the Schengen area should not exceed 90 days in a 6 month period. Please note that Australian and New Zealand visitors will need to present a valid Australian or New Zealand passport (validity at least 3 months on the day they leave Belgium), proof of sufficient funds and a return airline ticket.

Application form

One application form duly filled in, signed and dated by the applicant.

Photo

One passport photo not older than 6 months (dimensions: 35 by 45 mm).

Copy of visa status

Proof of your visa for Australia/New Zealand. Submit your up-to-date VEVO details for Australia or VisaView details for New Zealand. For another country, submit a copy of your residence permit.

Passport + copy

A valid passport:

- should have been issued within the previous 10 years;
- should be valid at least 3 months after the intended date of departure from the Schengen territory or, in the case of several visits, after the last intended date of departure;
- should contain at least 2 empty facing pages when applying for the visa.

Please provide one copy of the passport (the empty pages don't need to be copied).

Proof of a valid travel insurance policy

The insurance must be valid throughout all of the Schengen countries and must cover the whole duration of the stay or transit. The minimum cover is EUR 30,000.

The insurance must cover the cost of repatriation on medical grounds, urgent medical treatment and/or urgent hospital treatment or costs incurred in the event of death while in the Schengen area.

Travel arrangements

Reservation of return or round ticket, including a detailed itinerary. In case of an organized trip, include confirmation of the booking.

In the case of transit: visa or other entry permit for the third country of destination; tickets for onward journey.

Proof of accommodation

For the whole duration of the intended stay, including the full contact details of the lodging places (the names, addresses, phone numbers and email address or fax numbers of the lodging places).

Proof of civil status

If married or in a partnership, provide a copy of a marriage certificate or registered partnership agreement.

For minors (under 18 years old)

Student card (if available) + **Original letter from the school**, mentioning:

- full address and phone number of the school;
- permission for absence;
- name and position of the person giving the permission;

Please provide one photocopy of the card and the letter.

Parental Authorization:

- <u>If both parents or legal guardians reside in the country of applying</u>: Statutory Declaration with a permission to travel, from **both** parents or legal guardians, certificate of family relation or proof of custody, both certificates legalized by a Justice of the Peace, plus a copy of their photoID.
- If one parent or legal guardian is not present in the country of applying: Certificate of permission to travel and certificate of family relation or proof of custody, both certificates legalized by the relevant authorities in the country of residence, plus a copy of their photo ID.

Proof of solvency of the applicant

- Bank statements from the last 3 months, no deposits.
- Bank statements should not be "credit card statements" but bank statements of a current account where we can see you regular income (salary, pension, etc.).
- If staying in free accommodation: the applicant should prove that he/she has at least 45€ per person for each day of stay;
- If staying at a hotel: the applicant should prove that he/she has at least 95€ per person for each day of stay.

For retired persons:

Proof of pension or other regular income.

For unemployed adults:

• <u>If married</u>: Letter of employment and income of the spouse + copy of your marriage certificate.

If single/divorced/widow/widower: Any other proof of regular income.

NOTE

Attention! Guarantees for return (assessment of migration risk): the applicant is requested to provide as much information as possible to document his/her family background, professional and socio-economic status, ownership of land or real estate (for instance: proof of family bonds with his/her country of origin, proof of regular income and stable source of revenues from the applicant and/or his/her partner, proof of property, etc.). This information is essential to correctly judge the intention of the applicant to leave the Schengen area before the expiry of his/her visa.

Applicants who cannot enclose all documents from the list should consider adding alternative documents or explain the reason for not handing them in.

The applicant is hereby informed that submitting the above-mentioned documents does not guarantee automatic issuance of a visa.

Disclaimer

This checklist comprises all documents that are part of my visa application. I understand that the Embassy will decide on my visa application based on these documents only. I also understand that in exceptional cases additional documents may be requested by the Embassy, even documents that do not feature on this list at all.
