

Visa for Family Reunification to join Spouse (married to a Belgian citizen who resides in Belgium. (Art. 40 Ter)

Documents should be submitted in original + 2 photocopies (A-4 size). All originals are returned

Documents in Farsi language only are not accepted for the treatment of your visa file; only translated documents will be taken into account.

The Farsi documents need to be translated by a sworn translator into one of our national languages or into English.
