

**Study or study related stay (long stay visa).**

**Documents should be submitted in original + 2 photocopies (A-4 size). All originals are returned.**

Students who applied for a study under art 9-13 or 58 must fill a questionnaire at the Embassy of Belgium in Tehran after having lodged their application with VFS. The questionnaire must be filled on the day of application at 2 PM. (exchange students and students with scholarship from Belgium are exempted).

Documents in Farsi language only are not accepted for the treatment of your visa file; only translated documents will be taken into account.

The Farsi documents need to be translated by a sworn translator into one of our national languages or into English.
