studies of the applicant, by sending a monthly minimum of US\$ 400.00 (eight hundred dollars) and must be notarized and recognized by the Ministry of Foreigner Affairs of Angola (MIREX). Declaration and term may be replaced by documents proving the applicant's scholarship.

✓ For minors/under 18 years old, proof of guardianship is required, issued by a legal guardian in Brazil.

NOTE: For **specialization course in the fields of medicine**, documentation must also be presented, dully recognized by the consulate, that proves the completion of higher education or equivalent in medicine, nursing, dentistry or related area;
