4	Two way (flight, train or bus) ticket reservation (in accordance with insurance and accommodation).		
	Overseas travel medical insurance valid for all Schengen countries.		
5	The insurance has to cover the applicant for at least 30,000 euros or		
	equivalent, for all risks e.g. accident, illness, medical emergency, etc.		
6	Certificate of the sending and the receiving institutions duly		
U	signed and stamped by an authorized person.		
7	Provide evidence of suitable English or Bulgarian language		
	<b>ability</b> to be able to benefit from the education in case of students.		
8	Reservation(s) of accommodation for the whole period of stay (in		
	case of multiple city all reservations are needed).		
9	Translation of <b>birth certificate</b> (Shenasname)		
	Employer's certificate needs to contain the following: job title,		
	address, start date of employment, monthly amount of income and		
	salary slip of the last three months. Formal requirements: letterhead		
10	paper, stamp, and corporate signature.		
	Certificate from Tamin-e Ejtemaei (Social Security Organization) and		
	<b>Khadamat-e Darmani ( Health Services Organization)</b> also must be submitted.		
11	Detailed <b>bank account statement</b> of the past three months.		
	For minors a declaration by the legal representative on the coverage		
12	of the costs certified by notary public. If travelling alone or with one		
12	parent (legal representative), minors are requested to present a		
	declaration from the legal representatives / other legal representative.
