

## Checklist for Transit Visa

No	Documents Required	Yes	No
1.	<b>Visa application form</b> (fulfilled and signed personally by the applicant). If the applicant is a minor, signature(s) of the legal guardian(s) is required.		
2.	<b>Biometric photo, 35x45</b> , color, background must be white, the picture is not photographed for more than 6 months. Women should not have a scarf on his head - facial contours, neck and ears must be visible.		
3.	<b>Visa fee will be paid at the Visa Application Center (at VFS Global)</b>		
4.	- <b>Copy of visa</b> from country of destination (if required). - If an applicant can enter without visa it's necessary to submit <b>documents confirming his/her purpose of travel</b> , e.g. invitation, hotel booking, real estate documents, etc. at the country of destination.		
5.	Documents showing how costs will be incurred for the trip, for example: - Evidence of sufficient funds available during the stay - <b>bank account</b> issued in last 15 days(at least 50 euro per day besides the cost of hotel and flight reservation) minimum amount 500 euro (or equal in any other currency), and showing all transactions for the last 3 months. - If employed, <b>income for the last 3 months</b> .		
6.	Extract of <b>Turkish family book</b> showing place of residence, family link, civil status, parents, spouse, children and siblings. For non turkish citizens – valid <b>resident permit</b> will be required. <b>Historical address record</b> .		
7.	The following documents regarding the applicant's personal situation shall be presented by either of the categories: If Applicant is <b>employed</b> : - letter from employer and / or approval for leave (Certificate of employer: signed by Turkish employer and bearing the seal of the workplace, indicating the address and contact telephone number, position and salary rate). - SGK (social security) registration document and SGK "hizmet dokümü". If Applicant is a <b>Farmer</b> : Farmer certificate issued by Chamber of agriculture. If Applicant is employed by or owner of a <b>private company</b> : - Copy of the company registration in chamber of commerce and copy of the bulletin of the trade register. - Tax registration certificate of the Company. If Applicant is <b>retired</b> : Proof of pension (either bank account or pensioner booklet) If applicant is a <b>student</b> : Student certificate (Öğrenci Belgesi) <b>For minor applicant (age under 18)</b> : - Written parental consent in original. Document should be verified by a Notary Public in Turkey. This condition shall not apply, if the travelling parent or legal guardian is a single parent or holds the parental authority alone. -In case of traveling with parents, a letter of consent is also mandatory.		
8.	Airline reservations or documents showing the transport plan.		
9.	<b>Passport</b> or other travel document and copies of all the pages with stamps and visas and the last page with personal information. The passport should be valid at least a further six (6) months after the date of expiry of the visa. The passport must be issued within the last 10 years and shall contain at least two blank pages.		
10.	<b>Travel Health insurance</b> valid for Bulgaria, amounting to 30.000 euros and covers the actual dates of travel.		
11.	<b>Criminal Record with archival record</b> .		
12.	<b>Document stating entries and exits from country. For 5 years period. (Yurda giriş çıkış belgesi)</b>		

### ATTENTION:

The Consulate General of Bulgaria has the right to ask for any other additional documents it considers necessary, may call the applicant for an interview, and has a contractual right of refusal. In all cases the visa fee is non-refundable.
