| 5 | NO OBJECTION CERTIFICATE / SALARY CERTIFICATES The No Objection Certificate or Salary Certificate, must be addressed to the Cyprus Embassy in Abu Dhabi, including the Employer's Full Name, Complete Address and Landline Telephone Number, the document must include details regarding the Applicant's Position, Salary, Date of Recruitment. The letter must be originally signed and stamped. It must not be older than a month. | | | | | |
| 6 | BUSINESS OWNERS/PARTNERS should provide letter from the company along with a COPY OF TRADE LICENSE | | | | | |
| 7 | Dependent Applicants who are under Husband/Father Sponsorship should provide typed and originally signed NOC letter (issued by the sponsor, it must confirm the travel dates, exact purpose of travel, relationship, details of the applicant, and financial undertaking). Sponsor's residential address in the UAE and contacts details must be indicated in the letter. • Sponsor's Passport Copy • UAE Residence Visa copy must be attached. Original document must be sent from Cyprus. Scan copy is not accepted. Proof of Address – Document proof with Host's Name & Address. (E.g. Utility Bill, House Contract etc.) | | | | | |
| | If the Inviting person is in the UAE, then they have to prepare an Invitation Letter and Assumption of Responsibility and sign the documents at the Cyprus Embassy in Abu Dhabi prior to booking appointment at VFS. | | | | | |
| 15 | Minor Applicant (Under 18 Years Old) Both parents should be present at the application center. Letter, completed and signed by both parents or legal guardians, authorizing the minor to apply for a visa to enter the Republic of Cyprus. copy of the passport of each parent copy of the MINOR'S BIRTH CERTIFICATE (stating the parents' names; death certificate, where applicable). If 1 of the parents is out of the country or not living in UAE, that parent should visit the nearest Cyprus embassy to sign his/her NOC for the minor and send the original to the applicant. The original of the Bank Guarantee must be submitted to the aforesaid Department, while a copy of it, sealed by the Civil Registry and Migration Department, should be included in the visa application supporting documents. | | | | |
| | 2. | The Embassy may also ask for a copy of a Bank Guarantee Letter from the host, throughout a visitor's stay in Cyprus, to cover | | | | |
| | | the possible cost of repatriation. Bank Guarantee Letters are issued for: | | | | |
