



Dear Applicant

Your application and documentation will be delivered to the Embassy and your case will be processed by the Embassy as soon as possible.

Please read the requirements carefully. If any documentation is missing or incorrect, you must submit the documentation within 3 days from today. If the Embassy has not received the documentation by this deadline, a decision will be made on the case based on the present information.

One recent (less than six months old) passport-size photograph in color with white background and good resemblance. (3.5cm / 4.5cm).	
Passport , should be valid for at least three months (any other type of travel document should be valid for at least six months), beyond the intended duration of stay in Schengen and with at least two blank pages.	
Copy of Schengen visa and entry/exit stamps of the Schengen area from previous passports.	
Cover letter from the applicant stipulating the purpose of travel, duration, names of accompanying persons, transport and accommodation details.	
Overseas travel medical Insurance valid for all Schengen-countries. The insurance has to cover the applicant for at least 30,000 Euros or equivalent, for all risks e.g. accident, illness, medical emergency evacuation, Covid-19 etc. The policy has to clearly specify the period of validity and has to cover the entire duration of the trip including the date of arrival & departure.	
Flight reservations of return or round ticket. If applicant is traveling to several Schengen states proof of intra-Schengen Flight reservation, Train Itinerary or Car rental. The Embassy recommends that you do not buy a plane ticket before your visa has been approved.	
Proof of Relationship <ul style="list-style-type: none"> In case of visiting spouse living in Denmark - Copy of Marriage Certificate, if applicant is married and cannot provide evidence of marital status in the passport; copy of ration card, if applicable. Certificate proving existence of family relationship, if applicant is visiting close relatives	
Invitation from host. The embassy recommends that the host fills in an online VU2 invitation form at https://nyidanmark.dk/en-GB/You-want-to-apply/Short-stay-visa/Invitation-of-a-visa-applicant	
Evidence of legal residence of family/friends: copy of passport and residence permit card of host	
Proof of accommodation. Hotel reservations, rental of holiday home or campus residence reservation. If you intend to stay with a family member or a friend, proof of sponsorship and/or private accommodation from the host. If you are travelling to several Schengen states, proof of accommodation in each of them.	
In case of minors (< 18 years) travelling: <ul style="list-style-type: none"> A photocopy of Birth certificate If the minor is traveling with only one parent, written consent certified by public notary of the other parent or guardian, except in cases of a parent having sole custody or guardianship of the minor. If the minor travels alone (without parents), written consent, certified by public notary, from both parents or guardians having custody or guardianship of the minor. A photocopy of both parents' passports. If not, copies of the identification document (with signature and photograph) of the parents/guardians 	
Original personal bank statement with applicant's name showing movements in the last three months, duly stamped and signed by the bank: <ul style="list-style-type: none"> Should be provided by all applicants regardless of sponsorship and; It should indicate that you have the necessary means to pay for your stay and return trip. You must have at your disposal DKK 350 per day, if you are staying in a private home, if you are staying at a hotel, the amount must be greater, DKK 500 per day. You can find further information here: www.nyidanmark.dk. Not ensuring sufficient funds may lead to refusal of your application. 	
Evidence of source of Financial support: <ul style="list-style-type: none"> Indian income tax return acknowledgment for the last two assessment years; If the applicant is employed: <ul style="list-style-type: none"> Payslips for the last three months; Employment contract Holiday approval/leave letter from employer If the applicant is a company owner or self-employed: <ul style="list-style-type: none"> Certificate of registration of the company, including its goods and services tax (GST) registration number for companies based in India. If the applicant is sponsored: <ul style="list-style-type: none"> Proof of sponsorship If the applicant is retired: <ul style="list-style-type: none"> Pension statements for the last three months; Proof of regular income generated by ownership of property or business 	
Students - certificates of the establishment at which the applicant is enrolled.
