	Application form completely filled on https://applyvisa.um.dk/ , printed and signed by the applicant
	Visa Fee payment receipt printed from https://applyvisa.um.dk/
	One recent (less than six months old) passport-size photograph in color with white background and good resemblance. (3.5cm / 4.5cm).
	Passport , should be valid for at least three months (any other type of travel document should be valid for at least six months), beyond the intended duration of stay in Schengen and with at least two blank pages. Potentially copies of the most recent visas and stamps.
	A covering letter from the Indian organization/school containing: <ul style="list-style-type: none"> Name and date of birth of the applicant. An outline of the applicant's itinerary, purpose of visit, how/why the trip is relevant to his/her current studies, and the period of intended stay in Denmark/Schengen. Copy of student cards or certificates of the organization/school/establishment
	An invitation, entry ticket or enrollment confirmation from organization/school containing; name of the invited applicant, purpose of visit, dates of the intended stay, nature of costs being covered by host (boarding & lodging). <i>Preferably</i> a VU3 form signed with NEM-ID which can be found on www.newtodenmark.dk
	Overseas travel medical insurance valid for all Schengen-countries. The insurance has to cover the applicant for at least 30,000 Euros or equivalent, for all risks e.g. accident, illness, medical emergency evacuation etc. The policy has to clearly specify the period of validity and has to cover the entire duration of the trip including the date of arrival & departure.
	Flight reservations of return or round ticket . If applicant is traveling to several Schengen states proof of intra-Schengen Flight reservation, Train Itinerary or Car rental.
	Proof of accommodation : Hotel reservations, rental of holiday home or campus residence reservation. If you intend to stay with a family member or a friend, proof of sponsorship and/or private accommodation from the host. If you are travelling to several Schengen states, proof of accommodation in each of them.
	In case of minors (< 18 years) travelling: <ul style="list-style-type: none"> If the minor is traveling with only one parent, written consent certified by public notary of the other parent or guardian, except in cases of a parent having sole custody or guardianship of the minor. If the minor travels alone (without parents), written consent, certified by public notary, from both parents or guardians having custody or guardianship of the minor. A photocopy of both parents' passports. If not applicable, copy of birth certificate of applicant and, copies of the ID cards of the parents
	Original personal bank statement with applicant's name showing movements in the last three months, duly stamped and signed by the bank: <ul style="list-style-type: none"> Should be provided by all applicants regardless of sponsorship and; It should indicate that you have the necessary means to pay for your stay and return trip. You must have at your disposal DKK 350 per day, if you are staying in a private home, if you are staying at a hotel, the amount must be greater, DKK 500 per day. You can find further information here: www.nyidanmark.dk. Not ensuring sufficient funds may lead to refusal of your application.
	Evidence of source of Financial support: <ul style="list-style-type: none"> Indian income tax return acknowledgment for the last two assessment years; <i>If the applicant is employed:</i> <ul style="list-style-type: none"> Payslips for the last three months; Employment contract AND holiday approval/leave letter from employer <i>If the applicant is a company owner or self-employed:</i> <ul style="list-style-type: none"> Certificate of registration of the company. <i>If the applicant is sponsored:</i> <ul style="list-style-type: none"> Proof of sponsorship <i>If the applicant is retired:</i> <ul style="list-style-type: none"> Pension statements for the last three months; Proof of regular income generated by ownership of property or business
