The insurance has to cover the applicant for at least 30,000 Euros of equivalent, for all risks e.g. accident, illness, medical emergency evacuation etc. The policy has to clearly specify the period of validity and has to cover the entire duration of the trip including the date of arrival & departure. Certificate of the travel agency confirming the booking of an organized trip or any other appropriate document indicating the travel plans. Flight reservations of return or round ticket. If applicant is traveling to several Schengen states proof of intra-Schengen Flight reservation Train Itinerary or Car rental. People joining cruise liner in the onward journey, should provide the ticket & payment receipt. Proof of accommodation: Hotel bookings or accommodation guarantees covering the whole duration of the intended stay. | | | |
