(s)he qualifies as a person with health insurance services under social security, 2. (s)he has access to the Hungarian health insurance services within the framework of an international convention/treaty or agreement, 3. (s)he can cover the costs of his/her healthcare services based on documents in proof of his/her means of subsistence available in Hungary.
