- \* Original documents must be presented, additional photocopies may be required.
- \* The visa fee is non-refundable.

**ATTENTION:** The Embassy of Hungary has the right to ask any other additional documents it considers necessary, may call the applicant for an interview, and has a contractual right of refusal without any explanation. If there is a change in the submitted reservations, the Embassy of Hungary must be informed immediately.

By signing the checklist, I agree that the authenticity of my submitted documents can be checked by the Embassy of Hungary in cooperation with the Egyptian banks and authorities.
