CHECKLIST FOR MEDICAL TREATMENT VISA

<input type="checkbox"/>	Original application form duly completed and signed. Note: <ul style="list-style-type: none">For children under 18 years old, both parents must sign the application/declaration form.Passport copies of the father and mother have to be attached.	
<input type="checkbox"/>	Original passport with at least 2 empty pages and passport copy	
<input type="checkbox"/>	1 recent passport photograph (white background) – Not older than 6 months	
<input type="checkbox"/>	Original or copy of Travel/Medical Insurance covering the territory of the Member states of the Schengen agreement and with minimum coverage of EUR 30, 000 for medical expenses.	
<input type="checkbox"/>	Certificate of the receiving health institution including reference to the fact that the expected coverage of the medical treatment is available and accommodation is provided by the health institution. Please be advised that coverage of the medical treatment has to be proved beyond doubt if the latter certificate does not include reference to availability of the coverage or refers to the applicants own private or other sources.	
<input type="checkbox"/>	Confirmed flight reservations/booking (with either booking reference or ticket number).	
<input type="checkbox"/>	For non-GCC nationals: <ul style="list-style-type: none">Original employment certificate referring to the permission granted for leave duly signed and stamped by an authorized person of the business entity.Updated and recent salary certificate.Educational institution enrolment certificate referring to the permission granted for leave duly signed and stamped by an authorized person of the institution if the travel is taking place during the academic year.Original bank account statement of the applicant or in case of student his/her sponsor's, for the last six month duly signed and stamped by an authorized person of the bank.Original certificate of registration in case of self-employed duly signed and stamped by an authorized person.Kuwait residence permit must be valid for 3 months upon exiting the Schengen area.	
<input type="checkbox"/>	For Kuwaiti nationals: <ul style="list-style-type: none">Original salary certificate duly signed and stamped by an authorized person of the business entity. OROriginal bank account statement of the applicant or in case of student his/her sponsor's, for the last 3 months.Original certificate of registration in case of self-employed duly signed and stamped by an authorized person.Kuwait residence permit must be valid for 3 months upon exiting the Schengen area	

IMPORTANT NOTE:

- The visa must be applied in person.
- All documentation must be submitted in English or Hungarian language.
- Original documents must be presented; additional photocopies may be required.
- The Embassy of Hungary has a right to ask any other additional documents it considers necessary, or may call the applicant for an interview. If the visa application is refused, the reason will be provided as per Schengen Immigration Rules. In all cases the visa fee and service fee is nonrefundable.
- Head coverings is not permitted except for religious reasons, but facial features from bottom of chin to top of forehead and both edges of applicant's face must be clearly shown.

Declaration

I have been informed that an application without a complete set of documentation according to above mentioned checklist may result to the rejection of my visa application. The Embassy of Hungary reserves the right to ask for an additional supporting document and does not guarantee the issue of visa.
