

## VISITING FAMILY OR FRIENDS

1.	<input type="checkbox"/>	<b>Visa application, duly filled out in English and signed by the applicant (for minors: signed by parents or legal guardian) on site, upon application with blue ink pen.</b>
2.	<input type="checkbox"/>	<b>Two recent passport pictures</b> <i>Photo must be: 35 mm wide, 45 mm high, photo must be well contrasted, person must look straight into the camera, head must be straight, not tilted, mouth closed.</i>
3.	<input type="checkbox"/>	<b>Valid passport (plus one photocopy of biometric page)</b> <i>At least two empty visa pages, the passport must be valid for at least 90 days after requested trip and must be duly signed.</i>
4.	<input type="checkbox"/>	<b>UK Residence Permit and/or digital proof of immigration status issued by UK Home Office (share code).</b> <i>Original and copy (of both sides) of <b>UK residence permit</b> valid for at least one month beyond the intended departure from the territory of the Member States (or confirmed flight ticket to the country of origin) <b>and/or digital proof of immigration status issued by UK Home Office (share code).</b></i>  <i>In case of a UK resident permit issued before Brexit stating "Resident card of a member of a union citizen":</i> - <i>Proof of EU settlement residency status by share code issued by UK Home Office.</i>
5.	<input type="checkbox"/>	<b>Copies of previous visas issued in the last 3 years from any other Schengen country (if applicable) and of entry-exit stamps on the opposite page of the visas.</b> <i>If there are visas in the previous passports: copy of the biometric page of the old passport and copies of relevant visas and of entry-exit stamps on the opposite page of the visas.</i>
6.	<input type="checkbox"/>	<b>Evidence of applicant's socioeconomic status</b> <b><i>If the applicant is an employee:</i></b> <i>Recently issued (within 30 days of appointment), official and signed letter from their employer with name, date of issue, address, contact details, position of signatory and registration number in the United Kingdom. The position and salary of the employee should also be indicated <b>and</b> pay slips for the last three months.</i> <b><i>If the applicant is Self-Employed:</i></b> <i>Recently issued (within 30 days of appointment), official and signed letter from an accountant, banker or solicitor with name, date of issue, address, contact details, position of signatory and registration number in the United Kingdom, stating the nature of the self-employment or business ownership in the United Kingdom. The letter must also state the annual salary drawn from the company <b>and</b> self-assessment form edited by revenue and customs authorities.</i>  <b><i>If students applying (including children age of 18)</i></b> <i>Recently issued (within 30 days of appointment), official and signed letter from school, college or university in the United Kingdom stating date of issue, name of the applicant, type of studies, number of lessons (hours) per week and attendance record.</i>  <b><i>If the applicant is unemployed and receiving benefits or pension:</i></b> <i>Official proof of</i>

receiving benefits from the government

7.  **Proof of accommodation** or of sufficient means to cover the costs of accommodation. If relevant, such proof may be given through a proof of sponsorship by means of an official form (certificate of board and lodging).

8.  **Round Trip transports ticket booking**  
Proof of reserved return ticket to the United Kingdom, or proof of onward travel (if not returning to the United Kingdom), such as authorisation of entry into the country of destination, confirmed overseas ticket, proof of sufficient means to cover such costs. Tickets must show airports of departure and destination.
- If traveling by car, driving license, car registration and car insurance must be submitted alongside the return ferry tickets.  
If the driver is not the applicant, a cover letter + copy of the driving license of the driver is as well required.
- The ticket must show name of applicant as per passport.

9.  **Proof of funds**  
Nominative United Kingdom bank account statements covering at least the last three months and showing the current balance. Latest balance must be within 30 days of the appointment.
- Credit card(s) and credit card account statement indicating the cardholder's name and address. The statement must contain information on the monthly limit or the spending cap.

- If the applicant is financially supported by:**  
his/her spouse:
- a marriage certificate;
  - the spouse's bank account statements (see above); and
  - a statement of will to support the spouse.
- her/his parent(s):
- proof of family relationship, e.g. birth certificate;
  - the parent(s) bank account statement (see above); and
  - a statement of will to support the applicant.

10.  **(For children under the age of 18)**  
a) birth certificate; and  
**For minors travelling alone or with only one parent (exceptions are made if one parent has the sole custody or residence order for the child):**  
b) original passports of both parents, or certified copy of the biodata page of the passports;  
c) proof of consent of parental authority or legal guardian; and  
d) British school certificate.
- In the case of sole custody, the following documents must be submitted:**  
a) birth certificate mentioning one parent;  
b) death certificate of absent parent; or  
c) court ruling.

11.  **Documents proving the purpose of your travel:**

**Medical insurance Certificate**

- The insurance shall be valid for the territory of the Schengen Member States and cover the entire period of the person's intended stay or transit. The minimum coverage shall be EUR 30 000. The valid medical insurance has to also cover any expenses, which might arise in connection with repatriation for medical reasons, urgent medical attention and/or emergency hospital treatment or death, during their stay(s) on the territory of the Member States.
