1.	☐	Visa application, duly filled out in English and signed by the applicant (for minors: signed by parents or legal guardian) on site, upon application with blue ink pen.
2.	☐	Two recent passport pictures <i>Photo must be: 35 mm wide, 45 mm high, photo must be well contrasted person, must look straight into the camera, head must be straight, not tilted, mouth closed.</i>
3.	☐	Valid passport (plus one photocopy of biometric page) <i>At least two empty visa pages, the passport must be valid for at least 90 days after requested trip and must be duly signed.</i>
4.	☐	UK Residence Permit (plus one photocopy of back and front) <i>Original and copy of residence permit, valid for at least 30 days after coming back from the Schengen Area.</i> <i>In the absence of a UK residence permit card the following is also acceptable:</i> - Proof of right to reside in UK: share codes issued by UK Home Office for both the applicant and the EU Family member. <i>In case of a UK resident permit issued before Brexit stating "Resident card of a member of a union citizen":</i> - Proof of EU settlement residency status by share code issued by UK Home Office.
5.	☐	Copies of previous visas issued in the last 3 years from any other Schengen country (if applicable) and of entry-exit stamps on the opposite page of the visas. <i>If Visas are in old passports: copy of the biometric page of the old passport and copies of relevant visas and of entry-exit stamps on the opposite page of the visas.</i>
6.	☐	Original certificate of relationship and copies <i>Marriage or Civil partnership or birth certificate must be in English or Hungarian, clearly showing the applicant and spouse's names and surnames.</i> <i>Copy of EU member's passport</i> <i>In case the applicant changed their names, a change of name deed is requested.</i>
7.	☐	Original passport of the EU relative and copy of the data page. <i>In case of joining EU family member in the country of destination, proof that Applicant is joining the EU citizen.</i>

8.	☐	Joint (with EU family member) Round Trip transports ticket booking <i>Proof of reserved return ticket to the United Kingdom, or proof of onward travel (if not returning to the United Kingdom), such as authorisation of entry into the country of destination, confirmed overseas ticket, proof of sufficient means to cover such costs. Tickets must show airports of departure and destination.</i> <i>If traveling by car, driving license, car registration and car insurance must be submitted alongside the return ferry tickets.</i> <i>If the driver is not the applicant, a cover letter + copy of the driving license of the driver is as well required.</i> a. <i>The ticket must show name of applicant as per passport.</i>
9.	☐	(For children under the age of 18) a) <i>birth certificate; and</i> For minors travelling alone or with only one parent (exceptions are made if one parent has the sole custody or residence order for the child): b) <i>original passports of both parents, or certified copy of the biodata page of the passports;</i> c) <i>proof of consent of parental authority or legal guardian; and</i> d) <i>British school certificate.</i> In the case of sole custody, the following documents must be submitted: a) <i>birth certificate mentioning one parent;</i> b) <i>death certificate of absent parent; or</i> c) <i>court ruling.</i>
