· a certificate from the higher education institution maintained by a public trust with a public-service mission certifying that the higher education institution has received a financial donation from the applicant of at least EUR 1 000 000 to support educational, scientific research or artistic creation activities.

Documents in proof of means of subsistence in Hungary may be verified by:

- · a certificate from a credit institution under the applicant's name (e.g. a bank account statement, an account statement on savings or stocks and bonds, bank balance statement),
