1.	<ul style="list-style-type: none"> <li>▪ <b>Application form and Appendix no. 9.15 duly filled out in English and signed by the applicant on site upon application with blue ink pen.</b></li> </ul>
2.	<p><b>One recent passport picture</b></p> <ul style="list-style-type: none"> <li>▪ <i>Photo must be: 35 mm wide, 45 mm high, photo must be well contrasted, person must look straight into the camera, head must be straight, not tilted, mouth closed.</i></li> </ul>
3.	<p><b>Valid passport (plus one photocopy of biometric page)</b></p> <ul style="list-style-type: none"> <li>▪ <i>At least two empty visa pages, the passport must be valid for at least three months after the intended date of departure from the territory of the Member States and the travel document shall have been issued within the previous 10 years.</i></li> </ul>
4.	<p><b>Proof of right to reside in the UK (plus one photocopy of back and front)</b></p> <ul style="list-style-type: none"> <li>▪ <i>Original and copy of residence permit or British passport.</i></li> </ul>
5.	<p><b>Documents verifying the purpose of residence:</b></p> <ul style="list-style-type: none"> <li>· admission certificate of the educational institution providing scholarship training</li> <li>· a document certifying participation in the scholarship course,</li> <li>· any other credible evidence.</li> </ul> <p>A credible proof of the award of a scholarship provided by the Government or Ministry must also be attached.</p> <p><b>The following documents may serve as proof of the necessary language skills to participate in the training:</b></p> <ul style="list-style-type: none"> <li>· official certificate of language proficiency,</li> <li>· official certificate of studies in a foreign language,</li> <li>· any other credible evidence.</li> </ul>
6.	<p><b>Documents in proof of means of subsistence in Hungary</b> may be verified by:</p> <ul style="list-style-type: none"> <li>· a certificate from a credit institution under the applicant's name (e.g. a bank account statement, an account statement on savings or stocks and bonds, bank balance statement),</li> <li>· a notarised declaration made by a member of the applicant's family undertaking to provide for and support the applicant and a document certifying the ability of the person providing support,</li> <li>· certificate of regular income provided by an employer or tax authority,</li> <li>· any other credible evidence (e.g. a scholarship certificate).</li> </ul>
7.	<p><b>Documents proving that the applicant has a place of accommodation in the territory of Hungary:</b></p> <ul style="list-style-type: none"> <li>· residential lease contract,</li> <li>· a document on accommodation by courtesy,</li> <li>· a document in proof of ownership of the residential property,</li> <li>· a document in proof of the reservation of accommodation and payment for it.</li> </ul>
8.	<p><b>Documents proving the existence of comprehensive health insurance</b></p> <ul style="list-style-type: none"> <li>▪ Enclosed with the application for residence permit the applicant shall provide proof of having access to comprehensive health insurance services (in particular on the basis of</li> </ul>

specific other legislation on the social security system, international agreement, or under specific agreement), or that he/she has the necessary financial resources to cover the costs of such services.

9. ▪ **Documents evidencing the conditions of exit** may be verified by:
- a valid passport or the permits necessary for the third-country national for returning to his/her country of origin, or to the country he/she indicates;
  - and a valid ticket for departure, or sufficient funds to purchase such a ticket, or a means of transport lawfully used by the third-country national.

10. ▪ If the applicant is a minor, proof must be attached/enclosed that his/her parent or legal guardian has consented to his/her stay in Hungary. The parental consent must be recorded in a private or public instrument with full probative value, and must be attached/enclosed with Hungarian or English language translation.
