• Both parents should sign the registration form.		
● Form K - Duly filled and signed by both parents for Child's birth registration with Indian Authorities.		
● If Minor is unable to sign then provide a thumb impression and upload it while filling out the form online.		
● Attach copy of Applicant's birth certificate (Attested by JP or Notary) (NSW residents kindly submit documents attested by a Notary Public only, list of NSW notaries available at: https://notarynsw.org.au/find-a-notary)		
● Attach copies of passports of both the parents (First & Last page) - Attested by JP or Notary. (NSW residents kindly submit documents attested by a Notary Public only, list of NSW notaries available at: https://notarynsw.org.au/find-a-notary)		
● Copy of marriage certificate of parents.		
● Both parents should sign the declaration page of passport application Form.		
● Annexure D' - Duly filled and signed by both parents/legal guardian(s).		
● If Minor child has single parent/legal guardian and details of both parents cannot be submitted, ' Annexure C ' must be submitted (Attested by JP or Notary) (NSW residents kindly submit documents attested by a Notary Public only, list of NSW notaries available at: https://notarynsw.org.au/find-a-notary)		
● If you are applying child's passport after 1 year of his or her birth then provide a covering letter by mentioning the reason for not applying within one year of child's birth.



Photo Specifications



Guidelines for ICAO Compliant Photographs for Passport Applications

Here are the photograph guidelines as per ICAO standards to be adhered to photograph capturing or uploading for passport services.

- Close up of the head and top of the shoulders such that the face takes up 80-85% of the photograph.
- The photograph should be in color and dimensions should be 630*810 Pixels.
- Photos should be unaltered by computer software.
- Background of the photograph should be White.
- The photographs must –
 - Show the applicant looking directly at the camera.
 - Show the skin tones naturally.
 - Have appropriate brightness and contrast.
 - Show the applicants eyes open and clearly visible.
 - Should not have hair across the eyes.
 - Be taken with uniform lighting and not show shadows or flash reflections on the face and no red eye.
 - Mouth should not be open.
 - Be taken from distance of 1.5 meters from a camera (not too close) ◦ Should not be blurred
- It should have full face, front view, eyes open.
- Photo should be present full head from top of hair to bottom of chin.
- Centre head within frame (head should not be tilted).
- There should not be any distracting shadows on the face or in the background (should not have reflection of the glasses; glasses to be taken off to avoid reflections).
- Illumination shall not cause any red eye effects visible in the eyes or other effects reducing the visibility of the eyes.
- Head coverings are not permitted except for religious reasons, but the facial features from bottom of chin to top of forehead and both edges of the face must be clearly shown.
- The expression on the face should look natural.
