<ul style="list-style-type: none"> If your passport is Lost, submit a copy of the FIR / Police report (With Full name, Date & Place where the passport was lost). Without this your application can not be processed. Only Provision of Police report (Event) number is not acceptable.

<ul style="list-style-type: none"> If your passport is Lost or Damaged, you must submit reference letters from 2 Indian nationals (Residing in Australia) along with self-attested copy of their Indian passports (Front & Back page) 		
<ul style="list-style-type: none"> If your passport is Lost or Damaged, you must also submit copies of documents supporting personal details mentioned in your passport (Name, Date of Birth & Place of Birth)
